

C O N D I T I O N S

1. Compliance with Board's orders and /or instructions in any respect is obligatory on the part of the Authority of the Institute. Failing which it shall be deemed that the Governing Body has not been functioning properly and in that event the Governing Body is liable to be supergded.
2. The Institute must have land and building of its own or acquired on at least 99-year lease basis which must be vested in the Governing Body or competent authority of the Institute by Registered Deed, if not already done. A copy of such Deed should be submitted to the Board.
3. Accommodation should be made by providing at least 10 sft. of floor space per student in each class room. A statement to this effect should be submitted.
4. The space for games, physical Education etc. to engage at least 50 percent of the students at a time in active outdoor games shall be made available.
5. Recruitment of all Teaching and non-teaching staff including Principal shall be made by the Governing Body, as per regulation No. 20 of the Board. It is desirable that the members of the teaching and non-teaching staff should be paid their salaries and other admissible benefits according to Rules of the State Government Rules for recruitment of teaching personnel

in Govt. P.T.T.I. published in Govt. Notification No. 427-SE (Pr) dated 17th June, 1997 and Notification No. 852-SE (Pr) dated 17th August, 1998 should be followed only in respect of training and /or academic qualifications for appointment of all teaching staff.

6. The fees structure of the Institute regarding collection of fees from the trainee will be prescribed by the State Govt. in due course. Pending finalisation to the said structure the total fees and other charges collected from a student shall not exceed the recurring expenditure incurred per trainee of the institute for the year subject to the approval of the State Government.

The fees structure of the institute shall have to be got approved from the Board.

7. Library books on education, Reference, method of teaching etc. shall be provided and a statement to be furnished.
8. Multipurpose Educational Laboratory with different Sections has to be provided.
9. The requisite teaching appliances, apparatus, charts and other teaching aids should be made available and a list to be submitted.
10. An endowment fund of at least Rs 5 (Five) lakhs and a reserve fund of Rs. 1 (one) lakh must be kept invested in the fixed deposit scheme of any Nationalised Bank or Post

11. The admission process of trainees should be started forthwith with the publication of admission Notice to be given in at least two leading Daily Newspapers of the State -- one in Bengali and the other in English. The publication should be completed immediately within 7 (seven) days on or before 31st May, 2003. Duration of the courses is 1 (one) year and the session will commence from 1st July, 2003. Guidelines for admission of trainees (Non-Deputed and Deputed) in the Primary Teachers' Training Institutes for 2003-2004 is enclosed to be followed.

12. An undertaking must be submitted to the Board to the effect that the authorities of the Institute recognised shall abide by all orders, circulars framed by the Government of West Bengal and issued by the West Bengal Board of Primary Education from time to time.

## Guidelines for admission of Trainee in the Primary Teachers' Training Institute 2003-2004.

The admission process for trainees (fresher and deputed Candidates) should be started forthwith with the publication of Admission Notice to be given by the Institute in at least two widely circulated dailies - one Bengali and the other English Newspapers. The publication should be completed immediately within 7 (seven) days on or before 31st May, 2003. Duration of the courses is 1 (one) year and the session will commence from 1st July, 2003.

1. The total intake capacity of the Institute is to be divided into 75% for fresher and the remaining 25% of the seats for Deputed Candidates.
2. Regarding seats for reserved categories :-  
S.C. 25% S.T. 6% and Physically Handicapped 3%
3. Age limit for admission of Fresher Candidates :-

	Minimum	Maximum
(a) General -	18 Years	35 Years
(b) S.C./S.T. -	18 Years	40 Years
(c) Ex-Serviceman-	18 Years	35 Years
(d) Regarding De- puted teachers	18 Years	not above 50 years.

The upper age limit of teacher candidates may be relaxed further by the Chairman, District Primary School Council.

4. I.P.O. for Rs. 25/- (Rupees twenty five) only may be charged.

cations one crossed Indian Postal Order for Rs. 25/- only pay to the Principal/Lecturer-in-Charge, as the case may be, of the P.T.T.I. for meeting cost of interview and related prescribed expenditures.

- i. Accordingly candidates 5 times the number of seats meant for fresher candidates are to be called for interview as per prescribed norms in this regard and merit list would be prepared accordingly.
- ii. Higher qualified candidates will not get any bonus Marks. Selection of Fresher candidates will be made on the basis of results of S.F./M.P. or equivalent examination and oral interview & co-curricular activities.





1. Compliance with Board's Orders and / or instructions in any respect is obligatory on the part of the Authority of the Institute. Failing which it shall be deemed that the Governing Body has not been functioning properly and in that event the Governing Body is liable to be superseded.
2. The Governing Body of the Institute must be Constituted / re-constituted, if not already done, by 31<sup>st</sup> May, 2004 as per rules.  

The election of the Office bearers should be completed immediately after the placement of the Board's nominee on it without waiting further for any nominee / representative in default.
3. The Institute must have land and building of its own or acquired on at least 99 year lease basis. The construction work of the building, which was inspected for the Primary Teachers' Training Institute should be completed by June 2004.
4. No other fee / fees should be realized from the trainees beyond the amount and manner prescribed by the Board's circular. The Board may also withdraw recognition of such institution in case of violation of the Order.
5. An Endowment Fund of at least Rs. 5 (Five) lakhs and a Reserve Fund of Rs. 1 (One) lakh must be kept invested in the fixed deposit scheme of any Nationalised Bank for long term
6. The Admission process of trainees should be started forthwith with the publication of Admission Notice. The publication should be completed immediately so that the process of receiving applications for admission be completed upto 14<sup>th</sup> May, 2004. 9. No superannuated teacher should be appointed to the post of Principal and the lecturers of the institution.
